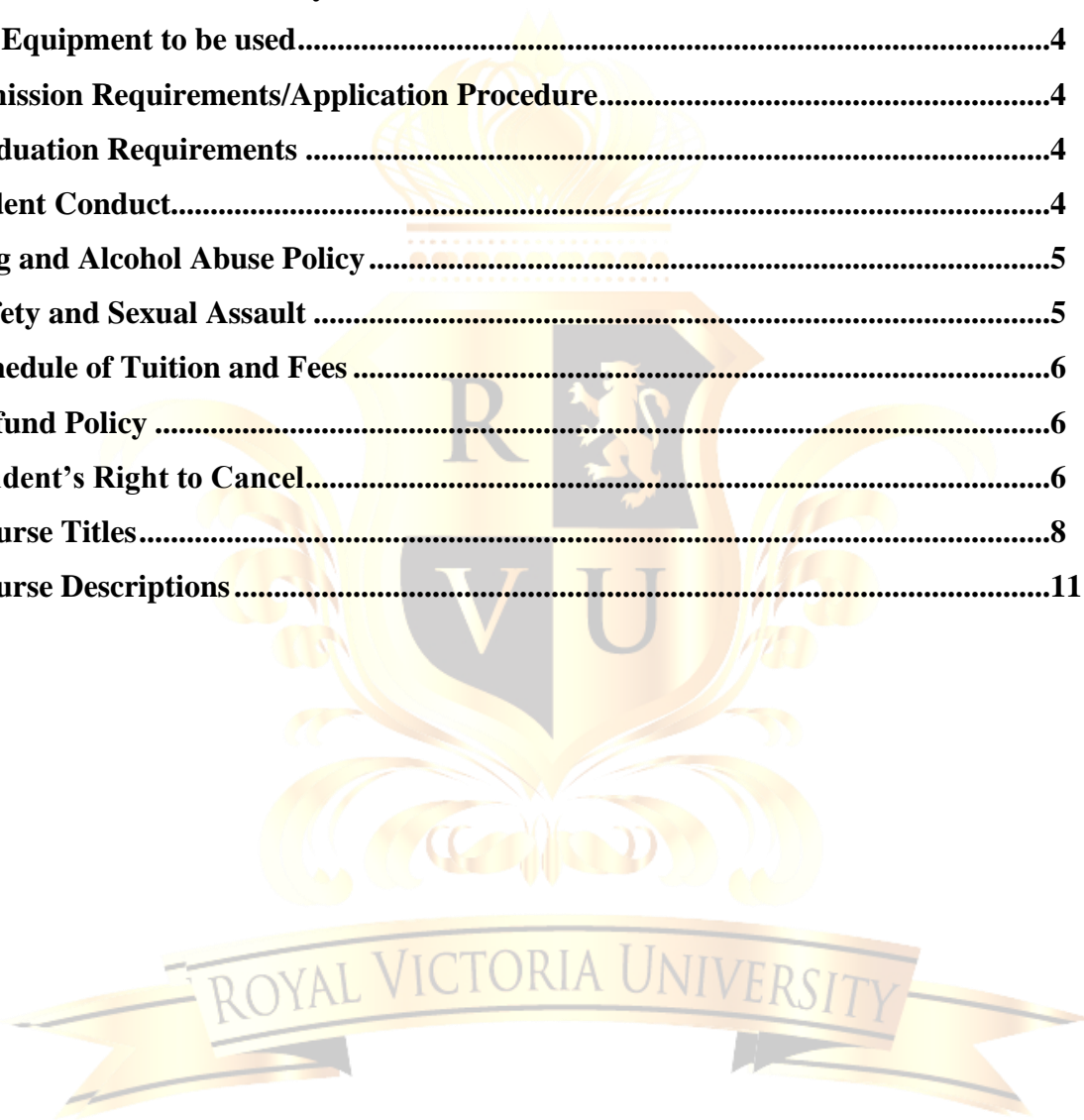

2. Fulfillment of all financial obligations to the University.

STUDENT CONDUCT

Students are expected to exercise respect and self-discipline at Royal Victoria University. The following behaviors may result in dismissal from Royal Victoria University:

1. Defacing, stealing or mutilating any school property.
2. Falsification or misrepresentation of material information in any records, financial documents, or sign-in sheets, whether inadvertent or deliberate.
3. Unethical conduct.
4. Activities creating a safety hazard to other persons at the University.

5. Disobedience or disrespect towards another student, an administrator, a faculty member or a staff member.
6. A single serious incident or repeated less-serious incidents of intoxication from any substance, as well as possession of drugs or alcohol on university premises.

DRUG AND ALCOHOL ABUSE POLICY

Royal Victoria University prohibits the use, possession, and sale of all alcoholic or illegal drug substances by any person in classes, seminars, or on campus property. Incidents violating this policy should be reported immediately to the Dean of Academic Affairs or Dean of Students. SAFETY AND SEXUAL ASSAULT

1. Royal Victoria University shall operate its facility with the goal of providing a safe environment to its visitors, students, faculty and staff. Royal Victoria University shall implement a notification process through which students, faculty and staff members may notify the institution of conditions, events, or individuals which may pose a threat to the safety of the individuals who use and/or occupy this facility.
2. Royal Victoria University shall provide for monetary resources necessary to maintain the building and its parking lot in such a condition to reasonably provide for the safety of the visitors, students, faculty, and staff members. Royal Victoria University shall ensure adequate lighting; removal of debris and spills; and timely repair of any and all objects which fall into disrepair, which shall in any way cause injury to individuals who are present on the premises operated by Royal Victoria University.
3. Royal Victoria University shall report to the appropriate emergency personnel any activity of any individual if such activity is deemed to be a threat to the safety of the visitors, students, faculty or staff members of Royal Victoria University.
4. Faculty and staff members shall report any breach of security to the President of Royal Victoria University. A breach of security includes, but is not limited to, theft, trespass, embezzlement, loitering, sexual harassment, assault, rape, and any other act, criminal or otherwise, which poses a threat to the security of the property of Royal Victoria University and the individuals who occupy and/or use the premises operated by Royal Victoria University.
5. Royal Victoria University shall educate its students and employees regarding sexual assault on campus and shall present to them information regarding the signs, dangers, and avoidance of sexual assault and the legal, medical and psychological help available to victims of sexual assault.
6. Royal Victoria University shall maintain strict confidentiality of all matters relating to any sexual assault which occurs on this campus, or which involves a student or employee of

Royal Victoria University; except as otherwise set forth in this policy statement information may be released to emergency personnel and law enforcement personnel in an effort to assist the victim and shall, whenever possible, be released with the victim's consent. No employee of Royal Victoria University shall release any information pertaining to a sexual assault on campus to members of the press, students, faculty or any third party unless the victim has given his/her written consent authorizing such disclosure, except as set forth above. Royal Victoria University shall make a reasonable effort to have those individuals who are present at the time of the incident sign a statement which provides for their agreement to maintain such matters in confidence as outlined herein.

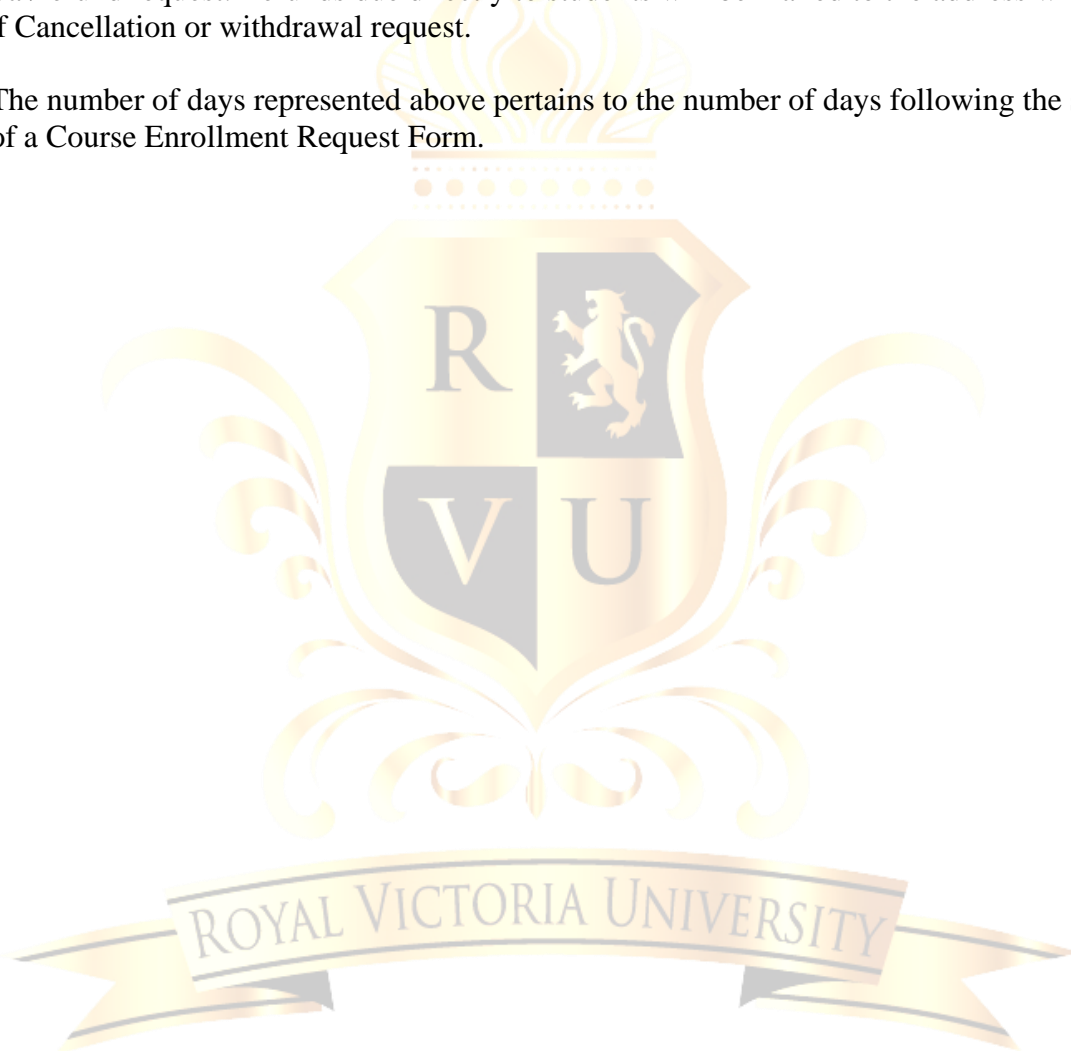

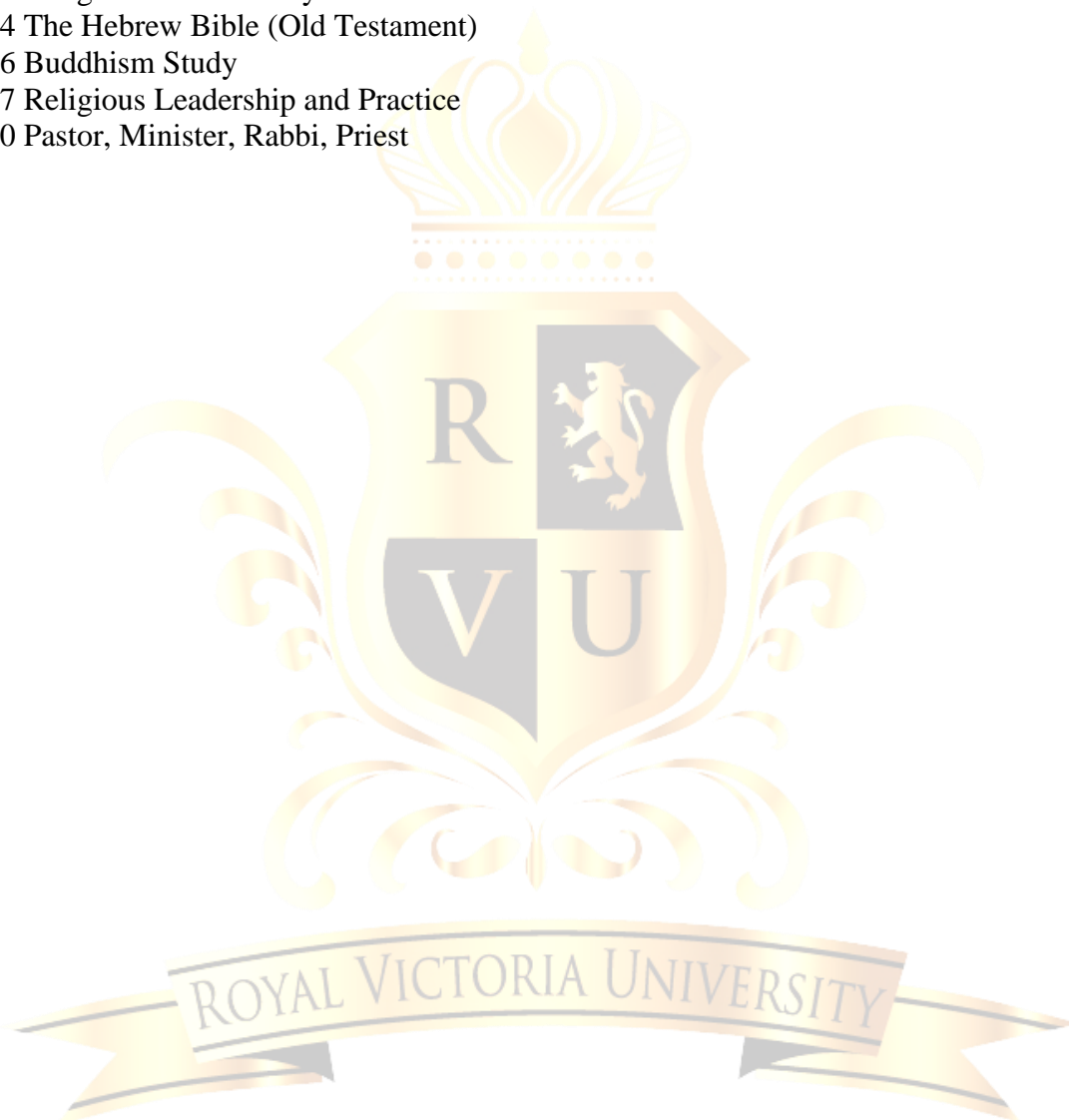

COURSE DESCRIPTIONS

AOM 1001 Acupuncture & Oriental Medicine (50 Hours - \$2,250.00)

This course of studies is designed to offer a sufficient understanding and overview of acupuncture & Oriental Medicine to already accredited Medical Doctors and Licensed Acupuncturist desiring to utilize acupuncture in their practice. Upon completion of this program, graduates will be able to apply this knowledge to augment the treatment of their patients.

The course will include:

- Philosophy of Traditional Chinese Medicine (TCM)
- Anatomy, Physiology and Meridian/Points
- Acupuncture Techniques
- Acupuncture & Oriental Medicine Diagnosis & Treatment

AOM 1002: Acupuncture & Oriental Medicine and Internal Medicine (30 Hours - \$1,350.00)

This course is a study of clinical oriental medicine dealing with syndromes of different body systems such as the respiratory, cardiovascular system. Consideration is given to etiopathology, clinical manifestations, analysis, and treatment plan, including acupuncture treatments and basic formula.

This Course also focus is on the TCM approach and researching internal diseases, including etiology and pathogenesis, type and treatment and prevention of the Respiratory System, Cardio-cerebra-vascular System, Digestive System, Urinary System, Blood System, Endocrine System, Infectious Diseases and Common tumors.

AOM 1003: Acupuncture & Oriental Medicine and Gynecology (30 Hours - \$1,350.00)

Gynecology is the field of medicine that deals with specific women's health issues, primarily those related to reproductive organs. This course applies the principles of Herbal Medicine and Acupuncture to the field of gynecology. More than twenty diseases are thoroughly discussed leaving students confident in the treatment of gynecological conditions with basic herbal prescriptions and acupuncture as well.

Course also focuses on researching female-specific diseases, including diagnosis and the TCM approach, postpartum and pregnancy disorders, and the latest techniques for the treatment of gynecological dysfunction.

AOM 1004: Acupuncture Sports Medicine (30 Hours - \$1,350.00)

The Program is for acupuncture practitioners who want to advance their skills in sports medicine as well as the treatment of pain. The course begins with a review of the important techniques used in the treatment of pain syndromes. We then cover in detail the diagnosis and assessment of over 20 sports-related injuries. This includes very precise instruction on palpation and orthopedic testing. After diagnosis, a systematic four-step approach is used as the "template" for all acupuncture treatment protocols. With instruction and supervised practice, each practitioner increases their knowledge and confidence in the diagnosis, assessment, and treatment of these common injuries.

Included in the program is an introduction to Korean Constitutional Acupuncture, techniques for the enhancement of athletic performance, and care of the athlete during training and competition. While the course is primarily focused on acupuncture, some Chinese herbal medicine, homeopathy, and western nutrition will be covered.

AOM 1005: Acupuncture & Oriental Medicine and Orthopedics (30 Hours - \$1,350.00)

This module introduces the fundamental TCM orthopedic theories, pain physiology, common tissue injuries, and differentiation of injuries to bone, muscle, tendon and ligament. Advanced meridian therapy, Chinese herbal therapy, scalp acupuncture, Tuina techniques, injuries to the arm, elbow, wrist, hip, knee and ankle, including tennis elbow, golfers elbow, carpal tunnel syndrome, tenosynovitis, osteoarthritis, sprains and strains of joints, meniscus injury, ligament injury, ankle sprain, and plantar fasciitis and other modalities in the treatment of lumbar spine and pelvic injuries, including scoliosis, acute low back pain, chronic low back pain, spinal stenosis, lumbar disc herniation, sacroiliac joint injury, piriformis syndrome. and other microsystem needle techniques for pain management are emphasized.

AOM 1006: Acupuncture & Oriental Medicine and Addictions (30 Hours - \$1,350.00)

This covers point locations and functions for withdrawal symptoms, how addiction complicates TCM diagnosis and treatment, and how to differentiate disharmonies common to each recovery phase. Additionally, the student will learn applicable Western clinical science information, updates on addiction and learn the role of acupuncture in the criminal justice system.

The Acupuncturists will:

- Attain information and become knowledgeable in the field of chemical dependency.
- Learn about use of acupuncture in this field, and consequently
- Capable of helping community by helping substance abuser population in their fight against the disease of addiction and also create more job opportunity as acupuncturist.

AOM 1007: Acupuncture & Oriental Medicine and Infertilities (30 Hours - \$1,350.00)

Practically, when TCM gynecologists consider an appropriate therapeutic strategy, they usually take account of the Western medical diagnostic techniques and test results to design an effective course of treatment.

This course concentrating on Women and Men Infertility, the Differentiation and Treatments may differently depend on diagnoses on Male or Female symptoms.

The following methods will be taught in this course:

- Acupuncture and Moxibustion Therapies
- Chinese Herbal Therapy
- Massage Therapy
- Chinese Folk Therapies

ACP 1008: Dental Acupuncture (30 Hours - \$1,350.00)

Profound potential to reflect and influence the health of the whole person, irruptions to the flow of energy through the mouth may affect remote regions of the body, and conversely, disruptions elsewhere may manifest in the mouth. We will treat your mouth considering the dental acupuncture points in order to treat your whole body.

Dental Acupunctures are known to reduce sensitivity to pain and stress, as well as promoting relaxation and deactivating the analytical brain, which is responsible for anxiety Acupuncture may help relieve dental pain by:

- Stimulating nerves located in muscles and other tissues, which leads to release of endorphins and other neurohumoral factors (e.g. neuropeptide Y, serotonin), and changes the processing of pain in the brain and spinal cord.
- Reducing the cardiovascular reflex elicited by toothache, which is associated with the adrenergic system.
- Increasing the release of adenosine, which has antinociceptive properties modulating the limbic
- Reducing inflammation, by promoting release of vascular and immunomodulatory factors increasing local microcirculation, which aids dispersal of swelling.

ACF 1009: Facial Acupuncture (30 Hours - \$1,350.00)

Students will learn a perfect blend of ancient practices and modern theory in the application of both acupuncture and massage applicable to the face. The techniques taught in this workshop are simple, safe, effective and efficient and can be easily applied to your client base.

Students will learn needling techniques from day one. Particular emphasis is placed on health and safety to effectively carry out facial/cosmetic acupuncture.

The Facial Acupuncture also covers:

- Traditional system
- New face system
- Combinations for pain management
- Cosmetic facial acupuncture
- Emotional release work
- Other facial systems
- Facial Cosmetic Acupuncture

ACP 1020: Acupressure & Massage Therapy (45 Hours - \$1,575.00)

The Core Acupressure & Massage Therapy Program at RVU provides lecture, hands-on training, practical experience and industry support those professionals needs.

This program will include Western massage modalities plus, in-depth training in Eastern Modalities:

Western Modalities:

Swedish, Deep Tissue, Lymphatic Massage, Sports Massage, Prenatal Massage, Aromatherapy & Spa Life, Foot Reflexology, Hot Stone Massage

Eastern Modalities:

Acupressure, Shiatsu, Traditional Chinese Medicine, Hand & Foot Reflexology, Energy Work, Rocking & Shaking, Thai Massage

HER 1201: Herbal Medicine (30 Hours - \$1,350.00)

An introduction to Chinese herbal medicine, this course presents the major herbs and herb groups in Chinese Herbalogy, with an overview of their herbal characteristics and therapeutic uses.

This course also examines in detail the herbal characteristics, entering channels, therapeutic actions, clinical indications, contraindication, dosages, preparations and special properties of the major medicinal substances in Chinese herbal medicine.

NUT 1210: Nutrition & Diets (Fundamental) (45 Hours - \$2,025.00)

NUT 1211: Nutrition & Diets (Advanced) (45 Hours - \$2,025.00)

This course covers nutrient metabolism and physiologic function in the body. Components of nutrition including macronutrients and micronutrients are discussed along with clinical applications.

The purpose of this course is to offer broad based knowledge in the areas of human nutrition & diets, including nutrition fundamentals, diagnosis and treatment of nutritional deficiencies and diseases, nutritional therapy and supplementation and nutritional weight loss.

ECO 6004: Economics (30 Hours - \$1,350.00)

Economics is an inherent part of our world. And, with every passing day, economics becomes more and more pivotal to our survival. From the items we buy at the store and our personal banking accounts to the types of industries in which we work, and the resources government employs to sustain our communities, we are surrounded by economically based challenges on a daily basis.

This Course will cover a wide range of economics topics, including:

- Microeconomics
- Macroeconomics
- International Economics
- Economics Regulation and Antitrust Policy
- Monetary Economics
- Economics of Environment
- Econometrics

ITR 6005: International Trade and Commerce (30 Hours - \$1,350.00)

Examines theories of international trade in goods and services and relates the insights to empirical evidence. Explains international trade at the level of industries and firms and analyzes the consequences of trade for resource allocation, welfare, and the income distribution. Discusses sources of comparative advantage, motives for trade policies, and the effects of trade barriers and trading blocs on welfare and incomes.

INV 6006: Investments (30 Hours - \$1,350.00) This course is designed for financial professionals and personal investors who recognize the importance of diversifying their investment portfolios and who have a desire to understand the risk and rewards of various trading styles in several asset classes. Instruction provides an overview of commodity futures and options, computer trading models, managed futures, commodity pools, diamonds, physical gold, Alternative Investments, and bitcoins. Topics include a history of futures and the exchanges; mathematical expectations behind many popular investing beliefs and “conventional wisdoms”; behavioral and emotional aspects of investing; orders, including entry and exit strategies, risk management, and measurement; income tax considerations; asset allocation and correlation and non-correlation studies; and an overview of trading data providers and trading software.

ADG 6007: Public Administration (30 Hours - \$1,350.00)

Analyzes the nature of public administration, its structure, and limitations; includes staff organization and chain of command, unemployment policies, personnel training and management, employees, organizations, and public relations.

Upon completion of this course, students should be able to:

- Explain what encompasses the field of public administration
- Explain what it means to be a public administrator
- Acknowledge that public administration is a wide-ranging and complex subject that involves core activities of government
- Explain the core activities provided by highly trained public administration experts and specialized organizations
- Explain the core purpose of public administration
- Recognize that public administration encompasses a large and dynamic portion of government at all three levels of the federal system, engaging even in nonprofit and private enterprise

HCM 6008: Health Care Management (30 Hours - \$1,350.00) Overview of key issues in the management and administration of comprehensive health care facilities. Focuses on the administrator's relationship to the medical and nursing professions and assesses the attributes of the various types of health service organizations.

This course will cover:

- Organizational Behavior and Culture in Health Care
- Economics of Health Care
- Human Resource Management for the Health Care Industry
- Legal and Ethical Aspects
- The Health Care Industry
- Industry Trends in Health Care Management

FIN 6009: Finance (30 Hours - \$1,350.00)

This course presents theories and their applications to demonstrate the advanced implementation of corporate finance. Students analyze stock and bond valuations, capital budgeting and working capital management, leasing, option pricing, risk/return, cost of capital, financial forecasting, capital structures, dividend policy, and investment banking. The implications of market responses to major financial strategies are also examined.

MAL 6010: Leadership & Management (30 Hours - \$1,350.00)

This course presents a comprehensive, integrative, and practical focus on leadership and management. It is based upon a framework that analyzes leadership and management at different levels: individual leadership, team leadership, and organizational leadership.

The course presents leadership and management theories/concepts that have emerged over the past several decades. It provides students the opportunity to apply these theories through case analysis and to enhance personal skill development through self-assessment exercises. Included in the course are identification of current leaders and leadership as well as contemporary perspectives on ethics, networking, coaching, organizational culture, diversity, learning organizations, strategic leadership, and crisis leadership.

MSP 6011: Sport Management (30 Hours - \$1,350.00)

The core curriculum explores the impact of sports on historical and modern society. Students learn industry fundamentals as they pertain to sports law, marketing, promotion, public relations, finance, and economics.

Students also have the flexibility to focus on a specific area of interest including sports administration for aspiring collegiate, community, or high school athletic officials. Concentrations include sports administration for the aspiring collegiate community or high school athletic official; coaching theory and strategy for those interested in leading sports teams; and a general concentration for those interested in business and front-office operations.

MAR 6012: Marketing (30 Hours - \$1,350.00)

This course is designed to provide you with an introduction to marketing. The course focuses on key marketing concepts, the role of marketing within organizations, and the role of marketing in society. Also explores the development of marketing principles and the role of marketing in an enterprise economy. Reviewing current articles and case studies develops an understanding of marketing principles.

This Course will cover a wide range of economics topics, including:

- Marketing Strategy
- Marketing Analytics
- Brand Management
- International Marketing
- Entrepreneurial Marketing
- Marketing Without Advertising
- E-Commerce
- Advertising
- Logistics

ITR 6005: International Trade and Commerce (30 Hours - \$1,350.00)

Examines theories of international trade in goods and services and relates the insights to empirical evidence. Explains international trade at the level of industries and firms and analyzes the consequences of trade for resource allocation, welfare, and the income distribution. Discusses sources of comparative advantage, motives for trade policies, and the effects of trade barriers and trading blocs on welfare and incomes.

MAP 6014: Project Management (30 Hours - \$1,350.00)

This course integrates project management theory with practical approaches to establish a fundamental knowledge base to use in a contemporary dynamic business environment. Explore project management concepts from planning and selection through all aspects of the project life cycle. Develop practical techniques to organize and control non-routine activities in order to properly manage and schedule quality, budget, and performance objectives.

MAH 6015: Hotel & Restaurant Management (30 Hours - \$1,350.00)

This course provides an overview of the lodging management industry. The student will have the opportunity to explore hospitality careers, food service, restaurant organization, hotels and hotel organization, meeting industry, management and leadership, human resources, marketing and selling, marketing communications, management companies, and ethics in hospitality management.

MAS 6016: Supply Chain Management (30 Hours - \$1,350.00)

This course examines procurement management decision making with the goal of understanding cost drivers and reducing cost impact while increasing procurement effectiveness. Emphasis is on creative methods for reducing or removing costs; inventory cost reduction; specifications and cost reduction; outsourcing; life cycle costs; statistical process control; value analysis; and setting cost ceiling incentives with the supplier chain, price-based costing versus cost-based pricing. Other topics include purchasing role in new product development; standardization; and dealing with uncertainty, types of compensation agreements. Post-award activities also are examined, and close-out issues and processes.

HRM 6017: Human Resources Management (30 Hours - \$1,350.00)

This advanced course is designed for HR professionals who wish to make an effective contribution at a strategic level in today's rapidly changing organizations, internally or as external consultants. Students will integrate the knowledge gained through previous coursework and experience and build on that conceptual foundation through lecture, class discussions, presentations, real-life case studies, and practical application. Emerging issues in human resource management will be discussed. Covered topics include transforming HR from the outside in, HR professionals as strategic partners, the six domains of HR competencies, advanced communication, and negotiation tactics for effective dialogue with senior management, designing strategies to re-engage employees and heighten productivity, understanding and addressing the increasing multi-generational issues, and implementing a retention strategy that addresses the needs of all generations. Advanced HR management skills such as consultation skills, coaching, change management, and facilitation skills will be explored and practiced. Students will learn how to safeguard their organization's bottom-line by acquiring the high-level skills needed to excel as an HR leader.

PRE 6018: Public Relations (30 Hours - \$1,350.00)

This advanced course is designed for professionals intended to provide theories, principles, and methods of public relations practice. The emphasis in this class is on problem solving and the tools and techniques of the trade as applied to real-life situations. The scope of the course is intended to present

the social, behavioral, psychological, ethical, economical, and political foundations of public relations and the theories of public relations as a communications discipline. This course will also examine the nature of various public relations audiences and the different channels used to reach them. The course will offer insight and perspective in determining the advanced public relations career for your profession. Written reports, oral presentations, in-class projects, and quizzes are an integral part of the curriculum.

TAX 6019: Taxation (30 Hours - \$1,350.00)

This course explores income taxation issues, including tax determination; personal and dependents exemptions; concepts and inclusions of gross income; general deductions and losses; deduction of certain business expenses and losses; depreciation, cost recovery amortization, and depletion; deduction of employee expenses; itemized deductions and losses; passive activity losses; property transaction gains and losses; nontaxable exchanges; and capital gains and losses.

TTO 6020: Travel and Tourism (30 Hours - \$1,350.00)

This course providing an overview of the structure and scope of the travel/tourism and hospitality industries. This course examines the components of the tourism industry: transportation, accommodation, food and beverage, and attractions. Other topics include the history, political, social and cultural impacts tourism has on local, state and global environments. Students will review marketing, motivation and other forces that draw more guests.

This course also will cover:

- Tourism & Community Development
- Cultural Tourism
- Global Issues in Travel & Tourism

REL 6021: Real State (30 Hours - \$1,350.00)

This course explores the techniques of financing commercial, industrial, residential, and special-purpose projects through the various phases of development: site analysis, land acquisition, plant development, construction, and marketing. Other topics include documentation procedures, legal aspects of real estate lending, interim and permanent lending procedures, use of income and expense statements, construction disbursement schedules, sales and leaseback, leasehold financing, and case studies and workshop problems.

This course will cover Global Real State, Property Management and Real State Development as well.

ENT 6030: Entrepreneurship (30 Hours - \$1,350.00)

Hone the ability to generate and implement new ideas and lead innovative teams and organizations. Taught by world-renowned faculty, these courses are engaging, interactive, and full of useful practices and strategies that can apply immediately:

- Use the design thinking framework
- Maximize success in early-stage enterprise
- Manage the interplay between ownership and growth
- Apply rapid prototype concepts
- Transfer technology ideas to market

PBUS 1010: Postdoc Course: Executive Leadership (50 Hours - \$2,250.00)

RVU Executive Leadership courses provide students with actionable tools, from leading through organizational change to negotiation strategies and providing students with the insights into what makes a leader exceptional. Students will explore complex issues such as self-awareness and learn skills to build a coalition of the willing, attract talent, and lead others to greatness. Students will return to their organization with the knowledge and skills to mobilize their team around a shared vision.

PBUS 1020: Postdoc Course: Executive Entrepreneurship (50 Hours - \$2,250.00)

These intensive workshops integrate scientific research, industry relevance and social benefit. Participants explore technology commercialization, intellectual property and new business development and build a network to move their idea forward. This executive level course also introduces participants to entrepreneurial global entrepreneurial network. It covers the entire venture creation process, from generating ideas to building viable global businesses, with a special emphasis on the nurturing roles of corporations, universities, governments, and foundations.

PBUS 1030: Postdoc Course: Executive Blockchain & Cryptocurrency (50 Hours - \$2,250.00)

The **Blockchain & Cryptocurrency Programs** is designed for those that wish to become competent Blockchain & Cryptocurrency broad range of Professional Certifications and who wish to embark on academic programs. The students may start a career as a Blockchain & Cryptocurrency business analyst, financial analyst, developer, banker or/and educational institution.

The Blockchain & Cryptocurrency course may include:

Blockchain: Understanding Blockchain, the Blockchain Ecosystem, Innovations in Value, Transfer, Decentralized Apps and Smart Contracts, Transforming Enterprise Business Models, Blockchain Frontiers, Blockchain Frontiers

Bitcoin Mining, Bitcoin and Anonymity, Community, Politics, and Regulation, Alternative Mining Puzzles, Bitcoin as a Platform, Altcoins and the Cryptocurrency Ecosystem, the Future of Bitcoin.

PBUS 1040: Postdoc Course: Advance Research & Project Methodology (50 Hours - \$2,250.00)

Covers advanced inquiry methodology and current research into the mechanisms underlying the various fundamental premises of Business. Emphasis is on fostering the understanding and ability to interpolate valuable information from between all the disciplines.

This course also deals with both the theoretical and practical aspects of designing project research and successfully defending the design in a project proposal hearing. The purpose of the course is to assist students through the Postdoctoral project processes.

INS 7001: Information Systems (40 Hours - \$2,200.00)

Fundamentals of information systems, what they are, how they affect organizations. Technical and organizational foundations of information systems, building information systems, managing information system resources. Laboratory emphasizes using computer to analyze, coordinate, and solve organizational decision-making problems.

The elements of modern formal logic and program semantics. Modern formal logic uses symbolic techniques for an analysis of validity, and related notations such as grammatical form and truth. This course addresses logical notations (syntax) and how to assign meaning to them (semantics), which are essential for an understanding of many aspects of contemporary philosophy, mathematics, and informal processing.

BUL 8001: Building & Construction (30 Hours - \$1,350.00)

Increase Architectural professionals, Engineers and construction professionals' knowledge and skills with professional courses.

ART 9003: Architecture & Interior Design (30 Hours - \$1,350.00)

COM 9010: Communications & Media (30 Hours - \$1,350.00)

The communications skills covered in this course will increase your ability to exercise choice and control for every type of conversation, influence with out authority and improve quality of relationships and productivity.

The topic may cover:

MUS 9020: Music Industry (40 Hours - \$2,200.00)

This course covers practical application of management concepts in the music and entertainment industry.

The business of music is a global multibillion-dollar industry comprised of individuals creating the music, and a whole lot of people doing everything else: working at labels, distribution companies, publishing companies, recording studios, artist management, promotion, producing, and legal counsel. If you are looking to further your career in the business end of the music industry, you cannot be successful without first understanding the entire industry as a whole. Music Business 101 presents a broad overview of the music industry and explains how its various segments operate on a day-to-day basis: where monies are generated, who the key players are, how deals are made and broken, how to protect our interests, and new developments in digital technology that are changing the way that music is marketed, promoted, distributed, and heard. This course presents the career opportunities that are available within the industry, and the knowledge people will need to achieve their goals.

FTI 9022: Film & Television Industry (40 Hours - \$2,200.00)

This class examines the nuts and bolts of Film and Television production, specifically from the Studio, Network, and Line Production perspective. Overviews of Game production, Animation production, Visual EFX and related practices will also be covered.

The syllabus follows the common practices and protocols of the Industry from Pre-Production, through Production and Post-Production, including discussion of the tangential marketing and distribution business sectors as they relate to Production Management.

The course also covers followings as well:

- Post-Production
- Feature Film Writing
- Film Scoring
- Television Writing

COF 110: Coffee: Science and Health (15 Hours - \$825.00)

Students participate in an overview of science behind of coffee. Caffeine can block different adenosine receptors in the brain, with varying effects. By blocking the A₁ receptor, which promotes sleepiness

when activated, caffeine can increase alertness. By blocking the A_{2A} receptor, caffeine can increase dopamine levels, which has stimulating and mood-enhancing effects.

The A₁ receptor doesn't seem to get desensitized, which may be why caffeine doesn't lose its awakening effect. The A_{2A} receptor does get desensitized, however, which is why coffee veterans don't feel true stimulation even after drinking several cups. The students also will learn:

1. Caffeine can enhance cognition
2. Caffeine can increase power output
3. Caffeine can help burn fat

TEA 110: TEA: Science and Health (15 Hours - \$825.00)

What is the science behind tea?

Exposing leaves to oxygen for a period of time determines the color, taste and strength of tea. The longer the leaves are left to oxidize, the darker in color and stronger in flavor they become. As you might imagine, black teas are highly oxidized whereas white and green teas are the least oxidized.

Key Terms of Tea

Fresh Tea Leaves – Harvested daily, the fresh growth of the plant is hand plucked, two leaves and a bud set.

Withered – The fresh leaves are laid into troughs, where they begin to wilt, and oxidation gradually starts. In most instances, forced hot air helps lower moisture levels in the leaves.

Shaded – To produce Matcha tea, tea rows are shaded twenty-one days before plucking to block sunlight and boost chlorophyll and theanine levels in the leaves.

Pan Fired – China green teas, such as Lung Ching (Dragon well), are pan fired in a wok to stop oxidation and retain their green color. Pan firing gives the tea a chestnut quality not found in other offerings.

Steamed – Japanese green teas, such as Sencha, are steamed after plucking. This stops oxidation and ensures that the leaves stay as green as possible.

Bruised/Rolling – Wilted tea leaves are bruised and rolled to encourage oxidation, a key step in making Oolong and black tea. Rolling breaks down the enzymes in the tea leaf wall and causes them to react with the oxygen.

Oxidation – The level of oxidation determines the kind of tea that will be produced. White and green tea have minimal oxidation. Oolong tea is partially oxidized: from 5% to 40%, and black tea is fully oxidized.

Fermentation – Shou Pu-Erh tea processing requires that the tea leaves be moistened and piled for about six weeks. This encourages microbial activity, which causes the leaves to ferment. This process was invented as a quick way to mimic the traditional aging process of Sheng Pu-Erh.

Dried/Fixed – After all processing steps are completed, tea leaves are dried to remove all moisture and stop oxidation.

DIV 1020 Introduction to the Study of Religion (30 Hours - \$1,375.00)

An introduction to the study of religion as cultural, social, and intellectual phenomena. The course teaches students how to interpret influential philosophical, social, scientific and theological theories. Students analyze aspects of religious systems-such as myth and ritual-across countries, regions, and ethnicities and produce a variety of writing assignments characteristic of the inherently interdisciplinary field of Religious Studies.

DIV 1021 Theories and Methods in the Study of Religion (30 Hours - \$1,375.00)

Within religious studies there are three common methodologies: Philosophy of Religion (Phenomenology), the study of religious communities (Functionalism), and the study of all aspects of the beliefs, practices, and experiences of the followers of a particular religion (Lived Religion).

DIV 1022 History of Christian Thought (30 Hours - \$1,375.00)

A survey of the development of Christian thought and history from the first century until contemporary times. This course will consider institutionalization of the Christian church and the development of Christian thought over the centuries. The course will also explore political and cultural influence on major theological positions.

DIV 1023 Religion and Economy (20 Hours - \$1,300.00)

Examines the interrelationships between religion and economics. Investigates the impact that religion has on economic, social, and public policy issues and how economics may affect religious beliefs, activities, and institutions. Connections will be made to various topics, such as trust, risk taking, beliefs, labor economics.

DIV 1024 The Hebrew Bible (Old Testament) (40 Hours - \$2,400.00)

This course examines the Old Testament (Hebrew Bible) as an expression of the religious life and thought of ancient Israel, and a foundational document of Western civilization. A wide range of methodologies, including source criticism and the historical-critical school, tradition criticism, redaction criticism, and literary and canonical approaches are applied to the study and interpretation of the Bible. Special emphasis is placed on the Bible against the backdrop of its historical and cultural setting in the Ancient Near East.

DIV 1026 Buddhism Study (40 Hours - \$2,400.00)

Buddhism is one of the world's largest religions and originated 2,500 years ago in India. Buddhists believe that the human life is one of suffering, and that meditation, spiritual and physical labor, and good behavior are the ways to achieve enlightenment, or nirvana, Social Studies, Storytelling.

The main focus of Buddhism study:

As expressed in the Buddha's Four Noble Truths, the goal of Buddhism is **to overcome suffering (duḥkha) caused by desire and ignorance of reality's true nature, including impermanence (anicca) and the non-existence of the self (anattā).**

DIV 1027 Religious Leadership and Practice (40 Hours - \$2,400.00)

This course is included but not limited to:

- Effectively communicate with faith leaders who can serve as potential partners
- Understand the faith of your clients, pastors and others
- Have the leadership skills to lead an organization through change
- Manage and lead organizations rooted in the reality of their location
- Develop budgets and identify resources for your organization to thrive and succeed

DIV 1030 Pastor, Minister, Rabbi, Priest (40 Hours - \$2,400.00)

This course of studies is designed to offer a sufficient understanding and overview of Pastor, Minister, Rabbi, Priest. The students also will study:
